CANOE / KAYAK INSTRUCTOR

GENERAL RESPONSIBILITIES

Plans, develops and conducts canoeing classes for campers at Piney Run Nature Camp. Directs the Canoeing Assistant, Camp Counselors, and campers in canoeing. Designs, writes and prepares canoeing lesson plans.
