**<u>GENERAL RESPONSIBILITIES</u>** Assists in the repair and maintenance of wastewater collection systems for the County in accordance with Federal, State, and local laws.

**ESSENTIAL TASKS** include the following; other duties may be assigned.

- 1. Assist in checking sewerage pumping stations, manholes and sewer lines
- 2. Perform facility and grounds maintenance and general repair
- 3. Perform electrical and mechanical maintenance of sewer lines, facility equipment, pumps, and motors
- 4. Maintain equipment and tools
- 5. Assist in conducting semi-final and final inspections of wastewater hook-ups and maintenance of right-of-ways
- 6. Complete routine paperwork such as time sheets, logs, and reports
- 7. Report to work outside of normal work hours for emergency operations
- 8. Perform related duties as to specific assignments
- 9. Any employee may be identified as Essential Personnel during emergency situations
- 10. Provide service to customers by answering questions, providing information, making referrals and assuring appropriate follow-through and/or resolution
- 11. Communicate with managers, supervisors, co-workers, citizens, and others, maintains confidentiality; and represents the County
